Otago's Faculty of Law has a vibrant, strong academic community and welcomes international students, who bring a highly-valued diversity and perspective.

You will be able to enjoy a close community environment with students from both New Zealand and many other countries, on a beautiful campus with world-class lecturers who are experts in their chosen fields.

The New Zealand Tertiary Education Commission ranked the University of Otago the highest in legal research in the latest round of the Performance-Based Research Fund quality evaluation. There are three research centres with international collaborations across a number of disciplines: The Legal Issues Centre, The New Zealand Law Foundation Centre for Law and Policy in Emerging Technologies, and the International Centre for Society, Governance & Science.

The Faculty offers a well-supported environment with an excellent law library and great IT. Students work collegially at the Faculty and there are dedicated law student associations – Society of Otago University Law Students, Te Roopū Whai Pūtake, and the Pacific Islands Law Students Association – who offer mentoring and support as well as organising many interesting and fun social events.
