Master of International Business (MIntBus)

The programme is designed to provide you with the knowledge and practical skills to work across cultural boundaries in the expanding global business environment.

The Master of International Business is the programme for you if you want to:

- Study at a business school ranked in the top 1% in the world (Equis, AACSB).
- · Gain access to research-informed teaching and supervision from academics in the Otago Business School's Department of Management, ranked #1 for research in New Zealand (PBRF Quality Evaluation 2018).
- · Obtain an internationally recognised degree.
- · Navigate the complex inter-connected world of international business and have a global career.
- · Conduct business and communicate effectively with other cultures.
- Understand business from a global perspective and make global business strategy decisions.



Key information

- The MIntBus commences in February each year.
- 12 months full-time study or 24 months part-time study.
- · Open to applicants who have a bachelor's degree in any discipline with a minimum B+ grade average in relevant 300-level papers.
- Applicants with equivalent alternative qualifications or experience are considered.
- Applicants for whom English is not their first language must have an IELTS (Academic) score of 6.5 with no band less than 6.

Teaching style and methods

The programme combines taught papers with either an applied project or a research project. The MIntBus offers a range of papers across a variety of business disciplines. If you have appropriate foreign language abilities, there is the opportunity to further develop these.

Career opportunities

The MIntBus prepares you for a wide range of positions in practically every sector of society that has an international focus. You might find yourself working for central government (e.g. Ministry of Foreign Affairs and Trade), travel and tourism organisations, financial institutions, global humanitarian networks, international sporting bodies, or in diplomatic and policy roles. Specific roles might include export manager, international business analyst, foreign exchange specialist, business consultant, international strategy analyst, trade negotiator, policy advisor or an academic.
