Methodology

- Mail survey of 1000 Dunedin residents
 - 600 "general" electorate members; 400 Māori electorate members
 - Overall response rate 49%
- Questionnaire examined:
 - Use of outdoor spaces with children
 - Probability of supporting smokefree outdoor policies
 - Attitudes to smokefree outdoor areas
 - Perceived policy outcomes

Overall, strong support for smokefree outdoor policies

Evident in attitudes, projected support and perceived outcomes

Support strongest from non-smoking groups

- But also evident among smokers
 - Suggests a low risk set of measures for politicians!
- Mandate to introduce these policies
 - Need to design and conduct evaluations to assess impact
