





"Localising" the Participant Information Sheet

Health and Disability Ethics Committees (HDEC) require that Participant Information Sheets clearly set out the local clinical contact the participant should contact if they have any study related queries or concerns. HDEC also require that it is clear which organization is conducting the study.

When preparing Participant Information and Consent forms, please use the current HDEC "Participant Information Sheet and Consent Form Template" which can be found on this page: https://ethics.health.govt.nz/guides-templates-and-forms/

For Participant Information Sheets and Consent Forms which have a contract with the Te Whatu Ora Health New Zealand and/or are carried out on Te Whatu Ora Health New Zealand – Southern premises, please use the logo for Te Whatu Ora - Southern.

For Participant Information Sheets and Consent Forms which have a contract with the University of Otago and/or are carried out on University of Otago premises, please use the University of Otago logo.

If you are unsure which organization your study is being carried out in, please contact Health Research South.

The official name 'Te Whatu Ora - Health New Zealand', can be shortened to 'Te Whatu Ora' (nothing else).

For Cultural Support:
