- 2. Maximum Timeframe of Completion is you must complete your programme within 150% of the minimum length of your programme measured in credit hours for undergraduate students and within the maximum period for graduate degrees as outlined in the Programme Regulations and Papers document; **AND**
- 3. PACE is you must maintain a satisfactory pace towards completion of your programme, which is completing 66.67% of all points attempted cumulatively during your programme.

Credit transfers awarded from previous study and count towards your programme are included in SAP for maximum timeframe and PACE (not GPA).
