## Master of Sustainable Business (MSusBus)

The Master of Sustainable Business is an interdisciplinary programme providing you with an advanced qualification in sustainability. Drawing upon emerging research in the field, this programme will position graduates for a wide range of career options in the public and private sectors, as practitioners and policy makers in positions such as sustainability managers, business analysts, sustainable business consultants and sustainability advisors.

## Why study the Master of Sustainable Business at Otago?

Industries, both in New Zealand and globally, are increasingly seeing the importance of having a good understanding of sustainability in everyday business operations. In response, the 12-month Master of Sustainable Business degree provides an in-depth consideration of one of the key issues of our time – how to manage an organisation while maximising social outcomes and minimising impacts on the natural environment.

It is the only course of its type in New Zealand and involves electives from across the University, allowing flexibility of the papers you study. The Otago Business School's Management Department is number one for research and sits within the number one business school\*. This means that teaching and course work are cutting edge, with projects that are practical and often involve working with companies on an issues they need help with.

## Key information

- Open to students who have completed a bachelor's degree in any discipline.
- Usually have achieved an average grade of B+ in the relevant 300-level papers.
- Have equivalent alternative qualifications or experience acceptable to the Pro-Vice-Chancellor (Commerce).
- 12 months of full-time study or 24 months through part-time study.

## Teaching style and methods

The programme resides with the Department of Management while offering electives from around the University. You will be taught using a mixture of lectures, small group discussions and readings, case analyses, and interaction with outside organisations. While completing the MSusBus you may be assessed in a variety of ways, including essays, individual and group presentations, research projects and final exams.

## Career opportunities

Graduates will have a wide range of career opportunities, both within New Zealand and internationally, in roles such as sustainability managers for industry, business analysts, sustainable business consultants, sustainable development managers and climate change advisors. There is a wide range of career options in the public and private sectors as practitioners and policy makers for sustainability involving low carbon strategies. New Zealand businesses that already employ people whose focus is on sustainability include Fonterra, Z Energy, NZ Post and Fuji Xerox.
