



## **Regulations for the Campbell-White Scholarship at the University of Otago**

The Campbell-White Scholarship was established in memory of the late Mr Charles Campbell-White, a graduate in Metallurgical Engineering at the University of Otago (1949).

Charles Campbell-White attended the University of Otago following a distinguished record as a fighter pilot in the Second World War. After graduation from the University, he worked for the Zinc Corporation in Broken Hill, Australia, which led to a role as senior metallurgist on the copper mines of Nchanga, in what was then Northern Rhodesia. Following a spell back in New Zealand, he moved to Elliott Lake, Ontario, Canada, where he was instrumental in developing the process of ion extraction of uranium from alluvial ore bodies. He was chief metallurgist for Newmont Mining on the O'Okiep copper mines in Northwest Cape Province in South Africa, followed by service as Chief Metallurgist in Rosebery, Tasmania. Back in South Africa in 1973, he worked as chief metallurgist for Phelps Dodge on the design and construction of the important Black Mountain Mine in Namibia. He spent ten years as a consultant to various mining companies until his final retirement in 1989.

This award will join an existing music scholarship set up in the memory of Mr Campbell's wife, The Patricia Pratt Scholarship. The Patricia Pratt Scholarship, which is administered by the NZVCC, is awarded for postgraduate study overseas.

### **Eligibility**

A candidate must be;

- a New Zealand citizen or a New Zealand permanent resident
- a student studying towards a full time degree of Bachelor of Surveying, Bachelor of Applied Science or Bachelor of Science majoring in Geology, Surveying or Applied Geology at the University of Otago.

A candidate's quality of leadership and community involvement will be taken into account, along with academic ability.

The grant is awarded by a selection panel.

Where no suitable applicant is found no award shall be made.

### **Value**

The value of the scholarship is currently set at \$3,000 per annum.

There will be one scholarship awarded each year, provided candidates of sufficient merit are available.

## **Tenure**

The scholarship must be taken up in the year in which it was awarded.

The scholarship may be held concurrently with another award or grant with approval from the selection panel.

## **Requirements**

The scholarship holder must agree:

- to submit a report on the year's activities to the Undergraduate Scholarships Officer by 1 December.

## **Publicity**

The University of Otago reserves the right to use the name, photograph, and details of the successful candidate for advertising and publicity. The scholarship holder must agree to be reasonably available to participate in interviews and promotional activities if requested by the University of Otago.

## **Application**

Applicants are required to submit:

- a letter (of not more than 500 words) explaining why they are a worthy recipient of the award.
- a short Curriculum Vitae.
- a copy of their University academic record.

The selection panel will include the Director of Development, the Director of the Applied Science Programme, the Dean of the School of Surveying, the Head of the Department of Geology and the Undergraduate Scholarships Administrator (or their nominees).
