## Parliamentarians and their (often missing) papers

Rags and riches would be a fair description of the Hocken Library's holdings of New Zealand parliamentarians' papers. Far too many rags — yet a few surprisingly good holdings for the use of present and future researchers.

The real tragedy is the number of old-time southern New Zealand political heavyweights of whom not a scrap is held. Dunedin's Vogel and Bracken, Central Otago's Pyke, Southland's Joseph Ward, and many others are not there at all. Even Stout is represented only by virtue of his widow's papers.

Many of the existing scraps are not much better. Imagine Robert Campbell, noted runholder and politician, represented by only a few cheque butts; Hyde Harris by a mere handful of letters; Sir John McKenzie by two notes to his storekeeper; Sir Thomas McKenzie by a single reply to a wellwisher.

Nor does parliamentary material figure much in the papers of such former MPs as W.Cargill (mainly N.Z.Company correspondence), G.M.Thomson (natural history papers), or Sir James Mills (shipping interests).

There are some notable compensations, though. The two biggest local collections to come into the Hocken before 1970 were those of J.T.Paul and W.Downie Stewart. Paul — unionist, Labour member, wartime censor and one-time editor of the Otago Witness — left a valuable selection of personal and party papers. And the 22 metres (about 80 boxes) in the Downie Stewart collection not only represent a different political standpoint, but also cover a diverse range.

The Hocken scored a coup when the significant papers of E.J.Howard (MP for Christchurch South 1919–39) and his politician daughter, Mabel, were unwanted by Christchurch institutions and Michael Hitchings brought them to Dunedin. We may not have Mabel Howard's famous bloomers, but we do have her handbag!

The modern trend began when archivist Peter Miller, aware of the need for a good set of parliamentary papers, approached Richard Walls when he had lost the Dunedin North seat. He missed by 48 hours. Having no means of bringing the contents of three filing cabinets back

to Dunedin, Mr Walls had consigned them to the Wellington tip.

Instead, an approach was immediately made to the new Member for Dunedin North, Stan Rodger, and thus began an annual deposit of parliamentary and constituency papers that continued over the next two decades. When historian Michael Cullen later joined the Labour parliamentary team and learned of the deposit arrangements, he in turn organised an annual deposit of his papers. Between them, these two Dunedin Cabinet Ministers have provided invaluable coverage of their own era. Although some restrictions are to be expected, both are already prepared to allow access to the bulk of the material, allowing more and more political research to be undertaken from Dunedin. The

papers of D.G. and Ethel McMillan have added further strength.

The Hocken Archives contain, of course, other important papers obtained from the various political parties and other sources, but a still wider coverage of parliamentarians' papers is obviously desirable. National Party Members are not well represented; nor are the Otago-Southland rural constituencies.

When one looks back at the pitiful remnants left behind to represent the hard work and social prominence of the region's earlier parliamentarians, the desirability of preserving much more informative archives on the contributions of our political representatives is all the more self-evident.
